Mr. Mariscal, Dr. Lerner, Ms. Powell, Mr. Stiger, Dr Steinhardt, Dr. Tyler, and Dr. Columbu, discussed mandatory adjustive technique.

Kristine Shultz gave public comment opposing non-mandatory categories.

Dr. Charles Davis gave public comment supporting non-mandatory categories.

Ms. Debbie Snow gave public comment opposing non-mandatory categories.

Dr. Bill Mecker gave public comment supporting non-mandatory categories.

Dr. Mark Brown gave public comment supporting non-mandatory categories.

Dr. Lubkin stated on page 7, number 5, 357(a) should actually be 357(b).

Mr. Mariscal recommended a change on page 7, number 6.

Ms. Powell recommended striking the last sentence of number 6 on page 7.

Kendra Holloway, Ms. Powell, Mr. Stiger and Dr. Lerner discussed the differences between a course and convention, and what is a fair agreement on what is a course.

Kendra Holloway commented on page 7, that number 3, 4, 5, and 6 are not criteria for approval.

Ms. Powell suggested changing numbers 3, 4, 5, and 6 to (d), (e), (f), and (g).

Kendra Holloway commented that record keeping of attendance should be left up to the provider.

Ms. Powell recommended a minor change to 357.1.

Mr. Mariscal and Ms. Powell discussed 357.1 (e), (f) and (i).

Dr. McCallister commented that 357.1 c needed consistency in regards to the under penalty of perjury statement.

Ms. Powell recommended a change to 358.8.

Dr. Lerner stated the medical profession allows CE credits for researchers; we should take a look at those regulations.

Dr. George Casey asked for clarification on 358.3 in regards to the definition of core curriculum.

Dr. Lerner responded that core curriculum is defined in the Initiative Act.

Dr. Mecker, Dr. Lubkin, Dr. Lerner and Mr. Mariscal discussed credit hours versus clock hours, and chiropractic research.

Dr. Steinhardt and Dr. Lerner discussed changing year of licensure to renewal period as a point of clarification.

Ms. Powell recommended a change to 359.

Mr. Mariscal discussed 359.
