Business and Professions Code section 901, which was repealed by its own terms operative January 1, 2018, created an exemption from the licensure and registration requirements for a health care practitioner licensed or in good standing in another state or states who offers or provides health care services for which he or she is licensed or certified through a sponsored event. As changes without regulatory effect, in response to the repeal of Business and Professions Code section 901, the Board of Chiropractic Examiners is repealing regulations pertaining to sponsored events.

OAL approves this change without regulatory effect as meeting the requirements of California Code of Regulations, title 1, section 100.
